

# INFORMATION ON THE TREATMENT OF PERSONAL DATA IN ACCORDANCE WITH THE REGULATIONS (EU) 679/2016.

In accordance with and by the effect of articles 12-14 of Regulation (EU) 679/2016 (hereinafter "GDPR"), Snam4Mobility (hereinafter the "Company"), in its capacity as Data Controller, hereby provides you with the information on the processing of personal data provided by you for registration on the website "www.iovadoametano.it".

### 1. Purpose and legal basis of the processing

The personal data provided during registration in the dedicated section of the site, the processing of which is strictly related to the management of the data in connection with the vision of the tutorial, will be processed by the Company for internal purposes only.

For the purposes described, when registering you will be required to provide some personal data such as personal data (Name, Surname, date and place of birth) and the details of a valid identity document.

We remind you that the processing of the above-mentioned data is compulsory because it is used, for security reasons, to ensure that you have viewed the tutorial for security reasons. Therefore, failure to provide the above-mentioned data will not allow the continuation of the registration activities nor the viewing of the tutorial itself.

### 2. Method of data processing

On the basis of the purposes indicated above, the processing of your personal data is carried out using computer and telematic tools designed to store, manage and transmit such data, solely for the purposes for which they were collected and, are always in such a way as to ensure the security and confidentiality of the company functions entrusted with the establishment, administration and management of the relationship, and whose staff has been suitably trained to ensure confidentiality and avoid loss, destruction, unauthorized access or unauthorized processing of the same data.

The processing of all data provided will always be logically carried out and through forms of organization of the same strictly related to the obligations, tasks or purposes described in this statement.

#### 3. Policy on the retention of personal data

The Company will keep the data acquired in its systems in a form that allows the data subjects to be identified for a period of time that do not exceed the achievement of the purposes for which they are initially processed and no later than the expiry date of the identification document provided at the time of registration.

At the end of this period, your personal data will be automatically deleted from our systems and you will be asked to register again.

# 4. Categories of persons to whom the data may be communicated

The personal data provided will not be disseminated, and will not be given to undisclosed subjects, in any possible form, including that of their provision or simple consultation.

However, your personal data may be made available to the Judicial Authority and/or the Police Force, upon their specific request, in order to identify the authors of any illegal acts committed to the detriment of the Company.

Personal data is not subject to disclosure to unspecified recipients nor are they transmitted abroad.

The complete list of such subjects or categories of subjects is available at our Company.

### 5. Data Controller and Data Processing Delegate

The Data Controller is Snam4Mobility S.p.A. with a registered office in San Donato Milanese, Piazza Santa Barbara n. 7.

The Delegate for the Processing of personal data on behalf of the Company Snam4Mobility spa is the *Senior Vice President* CNG BUSINESS.

The Data Processor is the supplier defined in the Application Maintenance contract, as System Integrator responsible for software application maintenance.

### 6. Rights conferred by law to data subjects

We inform you that in accordance with the articles 15-22 of the EU GDPR 2016/679, the interested party may exercise specific rights by contacting the Owner, including:

- a) Right of access: right to obtain confirmation from the Data Controller whether or not personal data is being processed and, if so, to obtain access to personal data and further information on the origin, purpose, category of data processed, recipients of communication and/or transfer of data, etc..
- b) Right of rectification: right to obtain the rectification of inaccurate personal data from the Data Controller without undue delay, as well as the integration of incomplete personal data, including by providing an additional statement.
- c) Right to deletion: right to request the deletion of personal data from the Data Controller without unjustified delay in the case that:
  - the personal data is no longer necessary with respect to the purposes of the processing;
  - the consent on which the processing is based is revoked and there is no other legal basis for the processing;
  - personal data has been processed unlawfully;
  - personal data must be deleted in order to fulfil a legal obligation.
- d) Right to object to processing: right to object at any time to the processing of personal data which have a legitimate interest in the Controller as a legal basis.
- e) Right to limitation of processing: right to obtain from the Controller the limitation of the processing, in cases where the accuracy of the personal data is contested (for the period necessary for the Controller to verify the accuracy of such personal data), if the processing is unlawful and/or the data subject has opposed the processing.
- f) Right to data portability: the right to receive personal data in a structured, commonly used and machine-readable format and to transmit such data to another data controller, only in cases where the processing is based on consent and only for data processed by electronic means.
- g) Right to lodge a complaint to a supervisory authority: without prejudice to any other administrative or judicial remedy, a data subject who considers that the processing of personal data relating to him/her is in breach of data protection law shall have the right to lodge a complaint to the supervisory authority of the Member State in which he/she resides or habitually works, or of the State in which the alleged breach has taken place
